Emily must choose between saving herself and protecting Jack when the FBI comes to investigate their missing agent.

Act One

EMILY THORNE and BEN HUNTER are sleeping. Ben's arm is draped over Emily's body, above the blankets. The sun is just barely shining through the open blinds. Act Two

She welcomes Natalie into her home. Natalie graciously accepts the welcome.

They walk together to the dining room. Natalie remains by Victoria's side and enters the room at the same time as Victoria. Victoria comments on good social graces, Natalie replies that they are equals. She reminds Victoria that she does

not have to pretend to be Queen with her. Victoria replies that she is not pretending to be anything. She offers Natalie a seat at the foot of her table. Natalie demurs and sits to her left instead.

Victoria awkwardly sits at the head. She asks about medieval courts. Natalie tells her to consider her a princess. Victoria nods and calls for their lunch.

Act Three

Jack is cleaning his bar as Agent Alexander Jones walks through the door. Jack tells him that the bar is closed. Agent Jones responds by showing his badge. Jack asks what he wants. Agent Jones implies that Jack already knows. Jack reasserts that the bar is closed.

Agent Jones looks around. He slides a picture across the bar. It is of Agent Kate Taylor. Jack looks at the picture. He looks up and asks Agent Jones what he wants. Agent Jones tells him that he and his partner are looking for Agent Taylor. Jack tells him that he hasn't seen her is a few weeks.

Act Four

Ben paces on Emily's porch. He knocks on the door and resumes pacing. He is holding the missing persons file. He knocks again. Emily comes up the stairs behind him. She asks him what he is doing there. Ben jumps and turns to face her. He shows her the file and asks to go inside. Emily opens the door.

Ben puts the file down on Emily's table. He asks her if she knows what it is. She looks at it. She tells him that it is a file from the police department. Ben asks her if she needs to tell him anything and she tells him to leave it alone. He pulls the other three files from under his shirt and puts those on top of the first file.

Emily repeats her command for Ben to stay out of it. He asks her how he can protect her if she keeps secrets from him. She tells him that she doesn't need protection and to leave. Ben scoops up the files and storms out of the beach house.

Emily sits on the couch and dials her phone. Her father DAVID CLARKE answers on the first ring. She explains that the FBI was sniffing around.
